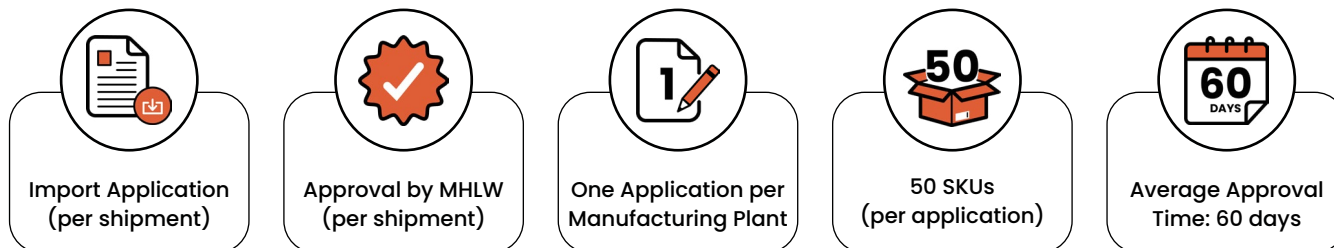


Electronics Import in Japan (Japan Radio)

Japan Radio is regulated in Japan by the Ministry of Economy, Trade and Industry (METI).

Steps

- 1 Submit your product information to COVUE compliance for pre-application review
- 2 Register your company under COVUE's license
- 3 Register your products with COVUE
- 4 Upload the original copy of Japan Radio certification
- 5 Product labeling with COVUE Japan Radio compliance label
- 6 Create a shipping invoice from the COVUE IOR account
- 7 Submit invoice to the shipping partner
- 8 Ship to the final destination

Application Requirements:

- List of products
- Manufacturing plant must be Japan Radio certified by an accredited agency (ex: TUV SUD)
- Copy of the Japan Radio certification with license number
- Japan Radio compliance labeling

Electronics Import in Japan (PSE)

PSE is regulated in Japan by the Ministry of Economy, Trade and Industry (METI)

First Shipment with COVUE

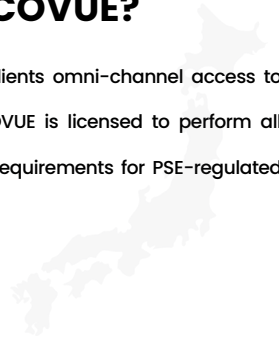


Note:

- Only a Japanese company licensed for import can legally import the product on behalf of the foreign seller.
- There are 2 types PSE Diamond and PSE Circle .
- requires a certified original copy of the manufacturing plant’s certification to JAPAN METI Standard, and the products or components to be imported must be listed.
- requires an email copy of the manufacturing plant’s certification to JAPAN METI Standard.

Application Requirements:

- Product technical information
- Manufacturing plant must be PSE certified to JAPAN METI Standard from an accredited agency (ex: TUV SUD)
- Product packing claims
- Permits and certificates
- PSE marks on products

Steps

- 1 Submit your product information to COVUE compliance for pre-application review
- 2 Register your company under COVUE’s license
- 3 Register your products with COVUE
- 4 Open Japan a PSE import application (notification)
- 5 Upload a copy of your manufacturing plant’s PSE certification
- 6 Submit the requested technical data
- 7 Japan Product Compliance labeling for PSE
- 8 Receive approval from Japan Ministry of Economy, Trade, and industry (METI)
- 9 Create a shipping invoice from the COVUE IOR account
- 10 Upload PSE product testing data results
- 11 Submit the invoice to the shipping partner
- 12 Ship to the final destination
